1. By-law No. 1004, Cabin Licensing – Amendment to General Plan By-law No. 898 – GPA 25-001

Mathew Dodds, Director of Planning and Development, presented By-law No. 1004, Cabin Licensing - Amendment to General Plan By-law No. 898 – GPA 25-001. Mr. Dodds advised that the amendment introduces provisions for cabins within the plan, updates the park's name to Iqaluit Kuunga Territorial Park, and updates the Watershed Protection Area to reflect current realities.
