

**THE MUNICIPAL CORPORATION OF THE CITY OF IQALUIT**

**BY-LAW No. 798**

**ALL TERRAIN VEHICLE BY-LAW AMENDMENT**

**BEING** a By-law of the Municipal Corporation of the City of Iqaluit in Nunavut to amend The All Terrain Vehicle By-Law No. 557.

**WHEREAS** the *Cities, Towns and Villages Act*, permits the City to regulate the use of vehicles and public safety;

**NOW THEREFORE** pursuant to the authority granted by the Act, the Council of the City of Iqaluit, in regular session duly assembled, enact as follows:

1) **That the interpretation section be amended by adding the following;**

"Abandoned vehicle" means a motor vehicle that is located on a highway and which;

- (i) Does not appear to be in operating condition; or
- (ii) Does not have attached to it a current plate issued under the *"The Motor Vehicle Act" of Nunavut; or*
- (iii) *Is wrecked, dismantled, partially dismantled, stripped or partially stripped;*

And which remains on a highway 72 hours after a notice described in subsection 7(11) has been attached to it.

2) **That Section 7(11) of the By-Law be added and the following subsections;**

7(11) The owner of a vehicle must not permit it to be abandoned.

7(11)(1) The notice referred to in the definition of "**Abandoned vehicle**" must include:

- (a) A description of the vehicle to which it is being attached, including the number on any plate attached to the vehicle;
- (b) The date and time it is attached to the vehicle;
- (c) A statement that, if it is not removed within 72 hours of the date and time the notice was attached to the vehicle, the vehicle will meet the definition of "abandoned vehicle" and will be taken to and stored in a suitable place;
- (d) An officer's number or other identification of the person issuing the notice.

(3) That Schedule B, be amended to include the following;

Offence	Section	Voluntary Payment
Owner abandon vehicle on highway	7(11)	\$100.00
Towing Fee	10	\$ 180.00
Storage and Impound –per day	10	\$ 20.00
Administrative Fee	10	\$ 15.00

This By-law shall come into effect on Third and Final Reading.
