The following change(s) in the Request for Quotation Documents are effective immediately. This Addendum forms part of the Contract Documents.

#### **Clarifications**

- **Q1.** Size of tires (diameter) and if there are any with rims on them?
- **A1:** The tires are a variety of passenger vehicle with some larger truck tires. The rims have been removed.
- **Q2.** Is all the hazardous waste packaged and ready for disposal or is the contractor responsible for gathering and packaging the waste?
- **A2:** The waste is packaged as described in the units of each item. Some items are self-contained (20' loaded sea container, which others are loos items (tote, cylinder of compressed gas, pallet of waste, 45-gallon drum). The bidder is responsible gathering
- **Q3.** Is the waste to be direct loaded on site?
- **A3:** Yes, the bidder is to take possession of the waste at the landfill site.
- **Q4.** What is the municipal address of the landfill?
- A4: 2085 Akilliq, Iqaluit
- **Q5.** Can we request a 2-week extension to the closing date to allow time to source the necessary requirements for this project?
- **A5:** The closing date will not be extended.
- **Q6.** What is the % of glycol in the antifreeze?
- **A6:** This was obtained from end-of-life vehicles, the concentration of glycol is unknown.
- **Q7.** What is the % of water in the waste oil? Is it mixed with anything else?
- **A7:** It is not mixed with anything else, percentage of water is unknown.
- **C1**: Citric Acid and waste paint has been removed from the scope of work. Please see the update cost submission form.
