The following change(s) in the Request for Quotation Documents are effective immediately.  
This Addendum forms part of the Contract Documents.

**Clarifications**

- C1.** The appended Cost Submission Form supersedes the previously provided Cost Submission Form. This cost submission form shall be used for pricing.
  
- Q1.** As part of the technical submittals that will be required for this project, as described in section 5.1 of Part VI - General Requirements, the Erosion and Sediment Control Plan as well as the Traffic Control Plan are indicated as “if applicable”. Please confirm whether these two documents will be required as part of the submittals and shall be included in the unit rates?
- A1:** These submissions are not required; however, the contractor must carry out the work in accordance with the conditions and requirements specified in the RFT documents.
  
- Q2.** Can you confirm if the totes of oil/fuel are plastic or steel? Any transport of fuel must be contained in a steel tank. If the totes are plastic, the oil/fuel will need to be transferred to a steel tank onsite.
- A2:** The totes are plastic with metal framing.
  
- Q3.** Can you please provide the dimensions and weight of each bottle listed in the provisional items so we can calculate shipping and disposal?
- A3:** Beyond what has been provided in the RFT documents to-date, no further information is available. Bidders are to provide unit rate pricing based on the information available.
  
- Q4.** Regarding the provisional Items, providing pricing for 1 item is challenging because there are minimal charges that are incurred to ship and dispose of each item. Can you consider adding a minimal amount per line item of a column for us to add a minimum quantity charge?
- A4:** The RFT has been created such that unit pricing can accommodate quantity removals as low as 1.

**Q5.** In Addendum 2 you mention the tires are a variety of passenger vehicle with some larger truck tires. Can you confirm the max size of tires? Will any of them exceed 44 inches in diameter and 16 inches in thickness?

**A5:** The majority of the tires are from passenger vehicles. A small portion of the tires are from water/sewer trucks.

**Q6.** What is the approximate quantity of tires?

**A6:** Beyond what has been provided in the RFT documents to-date, no further information is available. Bidders are to provide unit rate pricing based on the information available.

**Q7.** Addendum 3, A4 – We cannot provide disposal pricing for 45-gallon drums with unknown waste. A visual inspection during our site visit will not be sufficient to determine the contamination levels within the drums. Could you obtain and provide a chemical analysis of the drum contents so we can accurately provide pricing for disposal?

**A7:** Beyond what has been provided in the RFT documents to-date, no further information is available. Bidders are to provide unit rate pricing based on the information available.

**Q8.** Please provide dimensions for the 12 skids for Quatrex bags?

**A8:** Beyond what has been provided in the RFT documents to-date, no further information is available. Bidders are to provide unit rate pricing based on the information available.

**Q9.** Please provide dimensions for 12 bucket pallets of calcium hypochlorite?

**A9:** Beyond what has been provided in the RFT documents to-date, no further information is available. Bidders are to provide unit rate pricing based on the information available.

**Q10.** Addendum 3, A10 – Our shipping and disposal cost are based on weight. This is not something we can determine with a site visit. Could you please provide weights of all the items for bidding purposes?

**A10:** Beyond what has been provided in the RFT documents to-date, no further information is available. Bidders are to provide unit rate pricing based on the information available.
