*Wednesdays (times and groups may change depending on scheduling needs)*

(Age 6) Time: 5:30pm-6:30pm

(Ages 9-10) Time: 6:30pm-7:30pm

(Ages 11-14) Time: 7:30pm-8:30pm

- Iqaluit Minor Soccer is a for fun and fitness recreational program that is supported by parents volunteering. *If you are able to help out, please let us know.*
- The program will switch to a league structure in the second half of the season. More information will follow at that time.
- In an effort to have the program run smoothly, we have set up the following guidelines:
  - Due to supervision concerns and in order to reduce the number of children waiting, parents are asked to bring their child no sooner than **10 minutes** before their scheduled time and to pick them up promptly at the end. *Children will not be allowed to hang out at the AWG Complex following their soccer practice.*
  - Soccer clothing includes: shorts or sweatpants, t-shirt or soccer jersey. Indoor soccer shoes (**Without spikes**) or running shoes accepted. Please wear shin pads.
  - Outdoor gear and footwear is not allowed on the turf. Boots will have to be left in the entrance area of the turf
  - We ask that everyone respect the property. There are absolutely *no food or drinks* allowed on the turf.
  - Soccer players should bring their own water bottle with their name clearly marked on it and *filled with water only.*
  - There will be *no soccer on statutory holidays* that fall on Mondays or Wednesdays.

## Summer Minor Soccer

### Assumption of Risk

**While unlikely, there are some consequences to the physical activities that could cause serious injury.**

Activities that may be included during the minor soccer program include:

- Travel to and from sites for soccer activity sites including walking, taxi and bus transportation;
- Play on playgrounds /outdoor play structures, both designated and non-designated ;
- Sport activities both indoor and outdoor;
- Indoor and outdoor games;
- Competitive activities;
- Use of the inflatable bouncer;
- Special Events including BBQ's, camp fires, water games;

The City of Iqaluit Minor Soccer Program ("Minor Soccer") strives to provide a safe, clean and fun atmosphere.

In Consideration of my child's voluntary participation in the Minor Soccer in Iqaluit, Nunavut, including all Minor Soccer planned throughout the City of Iqaluit, I acknowledge and agree on behalf of myself and my child identified above that:

1. The risk of serious injury from participating in the Minor Soccer Activities, although minimal, does exist;
2. My child is physically fit to participate in the Minor Soccer and I agree that all Minor Soccer Activities are appropriate for my child;
3. I, for myself and my child, knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the City of Iqaluit and assume full responsibility for my child's participation at the Camp;
4. I and my child willingly agree to comply with the stated Terms and Conditions for participation and to obey the direction and requests of the City of Iqaluit staff. If I observe any hazards during my presence or my child's participation, I will remove myself and my child from the participation and immediately bring the said hazard to the attention of the nearest City of Iqaluit Recreation Department Employee;
5. I, for myself, my child and on behalf of my heirs, assigns, personal representatives, insurers and next of kin, **HEREBY WAIVE, RELEASE, AND HOLD HARMLESS**, the City of Iqaluit and its agents, employees, volunteers, officers and directors (collectively the "City of Iqaluit") from any and all claims, demands, lawsuits, actions, causes of action, complaints, litigation, costs (including legal costs or fees) or liabilities arising out of, or in any way related to, any loss, damage, expense or injury (whether to person or property) that I or my child may suffer as a result of my child's participation in the Minor Soccer, due to any cause whatsoever;
6. I **AGREE TO HOLD HARMLESS AND INDEMNIFY** the City of Iqaluit from any and all claims, demands, lawsuits, actions, causes of action, complaints, litigation, expenses, costs (including legal costs or fees) or damages (whether to person or property), of any kind or nature whatsoever, that they might suffer or incur arising out of or in any way related to my minor child's involvement or participation in the Minor Soccer; and
7. This release and waiver extends to all acts of negligence by the City of Iqaluit and is intended to be as broad and inclusive as permitted by the laws of the Nunavut Territory, and of Canada as applied in Nunavut, and if any portion of the agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
