

TOWN OF IQALUIT, N.W.T.

BY-LAW NO. 285

Being a By-Law of the Town of Iqaluit in the Northwest Territories to forgive certain debts owed to the Municipal Corporation, pursuant to the provisions of the Cities, Towns, and Villages Act, R.S.N.W.T., 1988, c. C-8, s. 164.

As the Council of the Town of Iqaluit is satisfied that certain debts owed to the Municipal Corporation are not collectable or should be forgiven for other reasons,

NOW THEREFORE, THE COUNCIL OF THE TOWN OF IQALUIT, in a duly convened meeting, enacts as follows:

1. All those debts owed to the Town of Iqaluit itemized in Schedule 1, attached to and forming part of this By-Law, are forgiven.

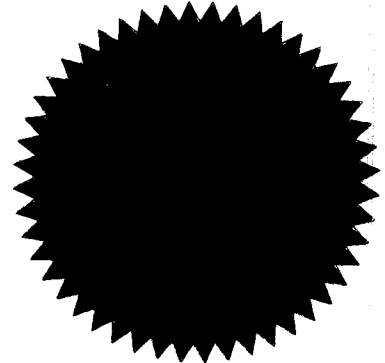
