BY-LAW 325

BEING A BY-LAW of the Town of Iqaluit in the Northwest Territories to forgive certain debts owed to the Municipal Corporation, pursuant to the provisions of the Cities, Towns, and Villages Act, R.S.N.W.T., 1988. c. C-8, s.164.


AS THE MUNICIPAL ADMINISTRATOR of the Town of Iqaluit is satisfied that certain debts owed to the Municipal Corporation are not collectible or should be forgiven for other reasons.

NOW THEREFORE, THE MUNICIPAL ADMINISTRATOR of the Town of Iqaluit, enacts as follows:


1. All those debts owed to the Town of Iqaluit itemized in Schedule 1, attached to and forming part of this by-law, are forgiven.

THIS BY-LAW 325 READ A FIRST AND SECOND TIME this 21st of day of September, 1994.

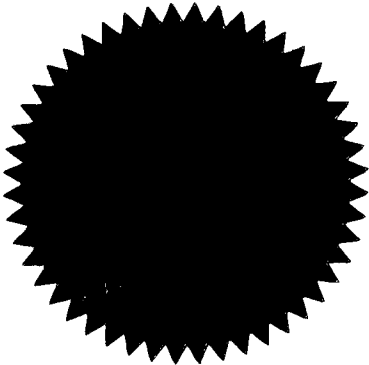
