#### **BY-LAW 565**

### **COUNCIL PROCEDURES AMENDMENT**

A By-Law of the Municipal Corporation of the City of Iqaluit in the Nunavut to make amendments to regulate proceedings in Council meetings and to establish the Terms of Reference for its Standing Committees pursuant to Sections 29-33 inclusive of the Cities, Towns and Villages Act, R.S.N.W.T., 1998, c. C-8.

WHEREAS it is in the public interest to make amendments on rules respecting procedures of Council.

NOW, THEREFORE, THE MAYOR AND COUNCIL OF THE CITY OF IQALUIT hereby enacts as follows:

# **SHORT TITLE**

1. a) This by-law may be cited as the <u>Council Procedures Amendment By-Law to existing By-law 526.</u>

If the Tuesday falls on a holiday, the regular meetings of Council shall be on the next regular working day at 6:00 p.m.
