# THE MUNICIPAL CORPORATION OF THE CITY OF IQALUIT, NUNAVUT BY-LAW No. 957

#### CHIEF ADMINISTRATIVE OFFICER APPOINTMENT

**BEING A BY-LAW** of the City of Iqaluit in the Nunavut Territory to provide for the appointment of a Chief Administrative Officer;

AND WHEREAS section 43 of the Cities, Towns and Villages Act, S.Nu. 2003, c.2 requires the municipality to appoint, by by-law, a Chief Administrative Officer;

**NOW THEREFORE PURSUANT TO** the provisions in the *Cities, Towns and Villages Act*, S.Nu. 2003, c.2, the Council of the Municipal Corporation of the City of Iqaluit, Nunavut, in regular session duly assembled, enacts as follows:

- 1. Repeals the Chief Administrative Officer Appointment by-law No. 875.
- 2. Replaces By-law No. 875 with the Chief Administrative Appointment by-law No. 957.

#### 1. SEVERABILITY

If any provision of this By-law is declared invalid because of any word, phrase, clause, sentence, paragraph or section of this By-law or any documents which form part of this By-law or an application thereof to any person or circumstance is declared invalid, the remaining provisions shall not be affected thereby, but shall remain in force.

#### 2. SHORT TITLE

This By-law may be cited as the "Appointment of Chief Administrative Officer By-law".

### 3. APPOINTMENT, TERMS AND CONDITIONS

Steven England is hereby appointed as Chief Administrative Officer of the Corporation of the City of Iqaluit, Nunavut, commencing the 13<sup>th</sup> day of June and ending either by way of motion and termination of the agreement by Council, or upon notice of resignation by the Chief Administrative Officer.

The Chief Administrative Officer shall carry out all powers, duties, responsibilities and functions in accordance with the *Cities, Towns and Villages Act*, S.Nu. 2003, c.2 or any other enactment.

#### 4. REPEAL

This By-law repeals By-Law No. 875.

## **EFFECTIVE DATE**

This By-law shall come into force upon receiving third reading.
