b) <u>Economic Development Committee Report</u> Councillor Morrissey, Chairperson

Councillor Morrissey read a report of a meeting held on January 14, 2013 at 6:00pm. The recommendations were noted as follows:

- development of a renewed community economic development plan
- potential projects and activities were incorporated into the economic
 development budget on January 14th: projects to include murals, a
 community market with stalls where hunters can sell to the local
 population, conduct more community clean-ups and garbage bins to help
 reduce the amount of litter throughout the city, better promotion for the city
 outside the territory, attendance at conference and events, an economic
 development portal on the city's website to assist residents in starting a
 business in the city, and a "Visit Iqaluit" video and web page aimed at
 attracting people and visitors
- two-day long meeting, bring all economic development organizations in the city together to discuss issues, challenges and how everyone can work together more effectively to provide services to businesses in Iqaluit
- Nunavut Tourism to present the results of the recent Visitors Survey to determine who is visiting and when; this will assist with the limited budget for promotion and ensure the city is receiving a good return on its investment

Colleen Dupuis, Chief Executive Officer of Nunavut Tourism, attended the meeting and presented the new tourism strategy that is currently being developed as well as the results of the visitor survey. There were several key points from her presentation including the tremendous potential lqaluit has as a destination for meetings, conventions and conferences at a national level, the potential for film crews to come and make movies, scene requiring snow, cold, ice, barren landscape, et cetera, publishing and distributing recreation schedules so that organizations know when the transition periods are between ice, turf, et cetera and much more.

She also indicated in her presentation that there is support amongst tourism's membership, including local hotels, to see a destination-marketing fee implemented which would charge a small levy on hotel rooms in the city; the consensus is that if the fee was small, and all funds generated were used to attract more visitors, it would be supported. The committee intends to follow up on this further and will be seeking Council's support.
