9. NEW BUSINESS

a) Public Safety Advisory Committee - Terms of Reference

Mayor Bell presented the Terms of Reference for the Public Safety Advisory Committee. He pointed out that under Membership, there are a number of organizations listed, but they have not yet been contacted.

Moved by: Councillor Stevenson Seconded by: Deputy Mayor Brewster

Council approves the Terms of Reference for the Public Safety Advisory Committee as amended.

Unanimously Carried

Councillor Stevenson asked for clarification under Membership (B) as it relates to the term, as three is written out and two is in brackets. He felt the term is supposed to be two years.

Councillor Stevenson noted that there is a membership list and asked if there were other community organizations in the future that would allow them to become a member of the committee. Mayor Bell pointed out that item 9 allows additional membership as recommended by Council and approved by motion of Council.

Councillor Sheppard noted that "the Committee shall be composed of" which suggests that if any member is missing, the Committee is not valid. He asked if the wording could be changed from "composed of" to "a seat will be offered to each of the following".

Deputy Mayor Brewster felt that there was a gap in the membership as it did not include two groups – youth and women and children, and they should be represented on the committee.

Mayor Bell commented that it was felt that the member from the Government of Nunavut (GN) Family Services would cover youth and women and children.

Deputy Mayor Brewster did not feel that GN Family Services would represent the two groups of citizens. She felt there should be a specific representative for women and children and a representative for youth.

Councillor Stevenson commented that having a member from an organization will bring the organization's vision to the committee, which he felt was important.

Councillor Stevenson asked for clarification if the youth representative would be represented by a member from a youth organization or would be a youth.

Deputy Mayor Brewster felt that the Arctic Children and Youth Foundation should be named in the membership list who could represent women and children, and possibly youth. She suggested the Inuksuk High School student body president or another youth representative as an option. She commented that this would be an opportunity to engage youth and include their perspective.

Councillor Stevenson noted that the Iqaluit District Education Authority has a youth representative and could be invited to sit on the committee.

Councillor Flaherty suggested that a preamble could be added under membership indicating that the committee will be gender balanced, as there are great women in organizations.

Councillor Akumalik was concerned regarding the purpose and objectives of the committee and suggested that air crafts, boating and construction be added. Mayor Bell agreed that these would be added to the list under Committee Purpose.

Mayor Bell advised that staff have made note of the requested changes to the Terms of Reference.

Councillor Sheppard pointed out that if Council approves the motion as presented, the Development Permit and variance will be approved and the public consultation will be irrelevant.

Amy Elgersma, Chief Administrative Officer, advised that staff listened to the audio from the Planning and Development Committee of the Whole meeting and it was clear that the wording refers to an amendment to the motion by adding a public consultation. Staff understands that the Planning and Development Committee is recommending that Council approve the Development Permit and variance, but a public consultation will be held prior to Council making a decision on the recommendation.

Councillor Sheppard expressed concern that the recommended motion should only have been the public consultation.

Councillor Stevenson asked for the date of the public consultation.

Ms. Elgersma explained that the request is for a public consultation and not a public hearing. The development officer is working with staff to prepare the documents to be distributed to the residents.

Councillor Fawcett noted that he had commented at the Planning and Development Committee of the Whole meeting that he intended to have a forum for people to speak and wanted a public hearing.

Council holds a public hearing on Development Permit Application DP 20-045 and further, that the entire area be invited to the public hearing.

For – Stevenson, Akumalik, Fawcett, Flaherty Opposed – Sheppard, Brewster, Awa Carried Councillor Sheppard was opposed to the public hearing, as the parcel of land already had a public hearing for the amendments to both the Zoning By-law and General Plan By-law. The change to the mixed-use of the building is a lower intensity use of what has already been approved for the lot and requires a variance for the additional two metres in height.

Councillor Flaherty agreed that residents in the area must be aware of public hearings.

Councillor Fawcett pointed out that it is not just a simple variance. The Development Permit Application is a brand new idea which was not provided to the residents. The previous approval was for a bar on the bottom. The new proposal is for a different venture on the bottom floor and the top three floors for apartments. Therefore, the development being presented for the lot is different than the previous development approval. Councillor Fawcett felt that the development requires input from the residents.

Councillor Sheppard noted that the issues being raised pertain to process. He noted that effective consultation is important and is needed when addressing proposed changes to the by-law. A public hearing is not required for a two-metre variance. He encouraged the importance of changing the by-law as it pertains to process.

Councillor Sheppard declared a conflict of interest and left the room.

Councillor Fawcett asked for clarification on the difference between public consultation and public hearing.

Ms. Elgersma noted that the *Planning Act* outlines the public hearing requirements. She explained that notices are delivered within a 30-metre radius of the said property and a public hearing is held in advance of a Council meeting, at which time the public is invited to voice their thoughts and/or concerns on the particular development.

She advised that a public consultation is a method that gains information and feedback from the public, which is then consolidated into a report and presented to Council. There are various methods used to disseminate information, such as the website and radio, and feedback is collected in various ways.

Councillor Fawcett felt that the radius for this particular matter should be extended to 150 or 200 metres, as the development will affect a number of residents, both in the area and people who will stay in the building.

Mayor Bell agreed that it was the intent to include the area, and staff are aware of this.
