3. DELEGATIONS

a) Traditional Inuit Burial

Maurice Schneiderman was in attendance on behalf of his wife, who is an Inuk Elder and wants to ensure that she is buried with her ancestors. Her ancestors are buried on the southern tip of Best Point, which is south of the two designated cultural heritage sites on Best Point. Mr. Schneiderman, on behalf of his wife, is requesting that the General Plan be amended so that the traditional Inuit burial area near the southern tip of Best Point be designated cemetery purposes, to ensure that his wife can be buried with her ancestors.

Mr. Schneiderman quoted from the General Plan and the Cemetery By-law. He stated that he is simply asking that a burial ground continue to be a burial ground.

It was noted that a Cemetery Committee has been formed and agreed that this matter be referred to that committee for review and discussion with a report back to Council.

Mr. Schneiderman noted that he is unable to speak publicly, and he is speaking on behalf of his wife tonight. He is therefore not able to speak before the Cemetery Committee. He explained that the area in question is difficult to access and not everyone would want to be buried there. He reiterated that he is speaking on behalf of his wife to ensure that she is able to be buried with her ancestors.

Deputy Mayor Brewster explained as a point of order that all City Council meetings are public, are recorded, and may be broadcast at a later date. However, committees of Council are not broadcast.

Councillor Sheppard asked Mr. Schneiderman if he could forward the written request to the Cemetery Committee and provide an explanation. Mr. Schneiderman agreed.

b) Iqaluit ETS (Ecole Des Trois Soleils) Addition

Present were Barry Cornthwaite, Manager, Capital Planning for the Department of Education; Justine LeClair, Parkin Architects; and, Daniel Nenadov, Accutech Engineering Inc.

Mr. Cornthwaite explained that Ecole Des Trois Soleils is being expanded to make the first kindergarten to grade 12 French school in Nunavut. Public consultation was held with the CFSN (Commission scolaire francophone du Nunavut), students, and staff. He noted there is a public meeting tomorrow (January 29, 2020) to provide input and ask questions.

The purpose of the presentation is to complete the public consultation with all the users and stakeholders in the school and obtain feedback to ensure the deliverable will have community use.

The following comments were made:

- The utilidor will be required to be re-connected.
- The school will have approximately 100 students.
- Consideration for a viewing space for the gymnasium.
- Maximizing the current views.
- Design schematic options will be available in three months.
- Size of expansion is 1500² metres which includes a gymnasium, four classrooms and additional support spaces.
- Estimated cost is \$10,000 to \$12,000 per square metre.
- Application has been made to Heritage Canada for some funding towards the public use portion such as the gymnasium, common areas and the classrooms that are used after school hours.
- Not aware if the Department of Education or the Community and Government Services have applied for funding for an Inuktitut school.
- Planning for expansion or constructing new schools for the Iqaluit District Education Authority.
 - Community and Government Services currently has Nakasuk School on pre-planning to develop a business case to present to the Department of Education. The Government of Nunavut then makes a decision for the entire territory.
- When designing the building, it is hoped it will be for both usefulness and aesthetically pleasing.

- Designing and building a school for education for students and teachers, but consideration is also given to the importance of having a community building with community spaces.

BY-LAW No. 886

2020 MILL RATE BY-LAW

A By-law of the Municipal Corporation of the City of Iqaluit in Nunavut to raise certain sums of money by way of taxation pursuant to the provisions of *Consolidated Property Assessment and Taxation Act* (Nunavut), R.S.N.W.T., 1988, Sections 76, 83 and 84;

WHEREAS the sums required as necessary, on the basis of the said estimated demands, after taking into account the said anticipated revenue and expenditures, as per Schedule “A” , Schedule “B” and Schedule “C” attached hereto;

NOW THEREFORE PURSUANT to the provisions of the Consolidated Property Assessment and Taxation Act (Nunavut) R.S.N.W.T. 1988 the Council of the City of Iqaluit, in regular session duly assembled, enacts as follows:

SECTION 1 – INTERPRETATION

In this by-law the following terms shall have the following meanings:

1.1 “Mill” means that taxation unit per thousand dollars of assessed value;

1.2 “Mill Rate” means the number of mills to be applied to a classification;

SECTION 2 – MILL RATE CLASSIFICATION

For the raising of revenue to meet estimated expenditures for the City for the year 2020, the following Mill Rates shall be applied to classifications:

2.1	Residential: Classification 7/8	19.35 Mills
	Residential: Classification 9/10/11	27.09 Mills
2.2	Commercial/Transmission/Transportation/Mixed Use	41.78 Mills
2.3	Industrial	46.00 Mills
2.4	Institutional	56.06 Mills

SECTION 3 - EFFECTIVE DATE

This By-law shall come into effect on the Third and Final Reading.

SECTION 4 - REPEALS

PROPERTY CLASSES BY-LAW AMENDMENT No. 861

A By-Law of the Municipal Corporation of the City of Iqaluit, Nunavut, to establish classes of property for assessment and taxation purposes passed pursuant to the provisions of the *Property Assessment and Taxation Act*, R.S.N.W.T., 1988, c. P-10 Section 15.

As it is in the public interest to establish classes of property for taxation and assessment purposes;

WHEREAS the Council of the Corporation of the City of Iqaluit has adopted a Property Class By-Law (By-Law No. 861), in accordance with the *Property Assessment and Taxation Act*, R.S.N.W.T., 1988, c. P-10 Section 15 and

WHEREAS Council wishes to amend the Property Classes By-Law by adding additional classes.

NOW, THEREFORE, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF IQALUIT, at a duly assembled meeting, enacts as follows:

1. comprised of, to include the following:
 - l) Class 12 – comprised of property principally used for publicly and privately owned facility of an institutional or community service nature.
 - m) Class 13 – comprised of property principally used for transportation, including air, sea and road transportation and for related communication facilities.
2. This by-law shall come into effect on the date of its Third and Final Reading.

LAND DISPOSAL BY-LAW

A BY-LAW of the City of Iqaluit, a Municipal Corporation in Nunavut authorizing the City to dispose real property, pursuant to Section 53.5(5) of the Cities, Towns and Villages Act, R.S.N.W.T., 1988 c.C-8;

AND WHEREAS certain land and/or improvements are available for disposal by the City of Iqaluit;

NOW THEREFORE the Council of the Municipal Corporation of the City of Iqaluit in a duly assembled meeting enact as follows:

1. That the Municipal Corporation of the City of Iqaluit is hereby authorized to dispose of the portion of road as listed in the attached Schedule "A" which forms part of this by-law.
2. That the Mayor and Chief Administrative Officer of the City of Iqaluit, or lawful deputy of either of them, are hereby authorized in the name and on the behalf of the City of Iqaluit, to execute all such forms of application, deeds, leases, indentures, and other documents as may be necessary to give effect to this By-law and to affix thereto the corporate seal of the City of Iqaluit as the act and deed thereof, subscribing their names in attestation of such execution.
3. That this By-law shall come into effect upon receiving third reading.

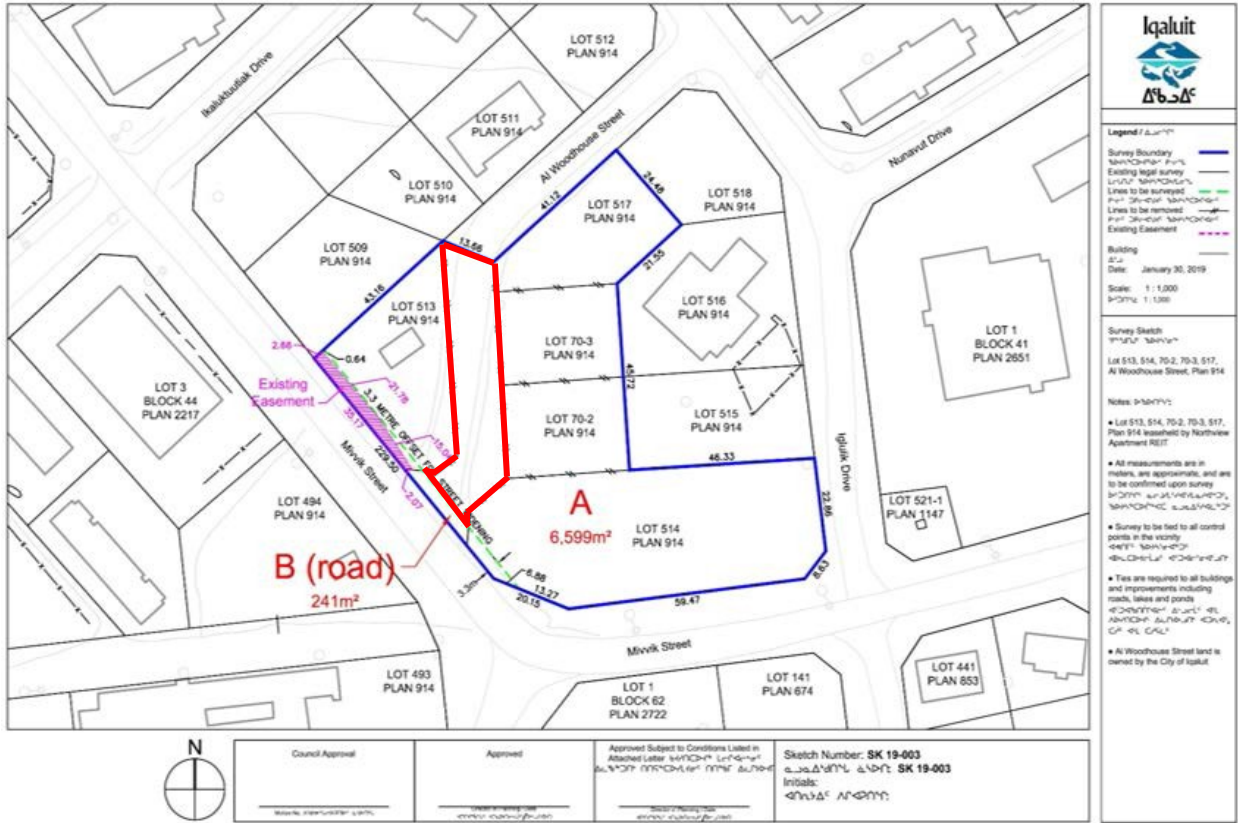

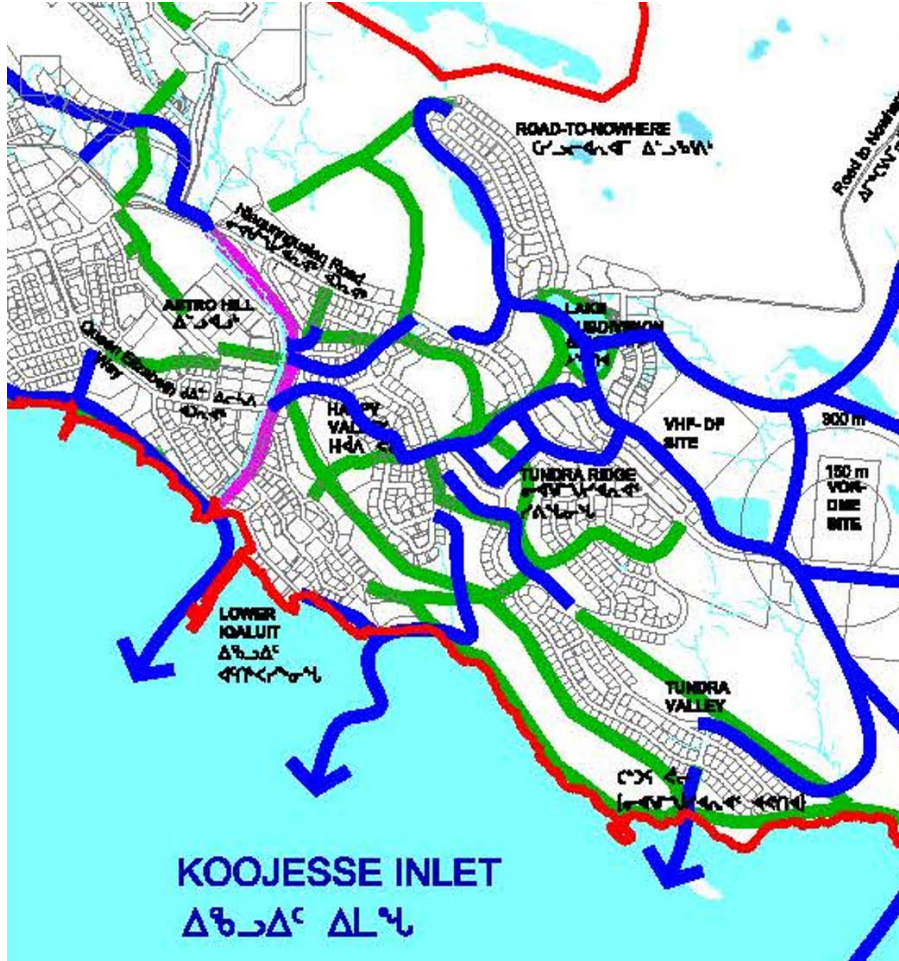

We are seeking a hamlet council member to hold a chair on the oversight committee for the project (Commitment of a 1-hour phone call every quarter and an annual in-person workshop once a year. Honoraria provided if required.) If you cannot, could you recommend someone else from your organization to take part?

Oversight Committee role

Part of our project is to establish an *oversight committee* to provide us guidance and act as local leads on the project. This guidance could be on anything from financial matters (e.g. how much to pay marine monitors in the community to perform sampling work) to how to properly engage with the broader community and gather input. We are very interested in having you or someone from your team be part of our oversight committee to make sure we get your input as the project moves forward. COMMUNITY FISHERS

Community Fishers empowers community members to easily contribute high-quality data on water properties to help better understand fish habitat and the changes that may be impacting the ocean environment over time.

Community Fishers is a practical and user-friendly mobile application that allows community members to collect ocean data by coupling a smart tablet with oceanographic sensors. This technology allows owners of vessels of opportunity—fishing boats and pleasure craft—to collect ocean data from a wide range of sensors, such as temperature, salinity, and pressure, using a conductivity-temperature-depth (CTD) instrument. There are no known impacts to wildlife and nothing is left in the water.



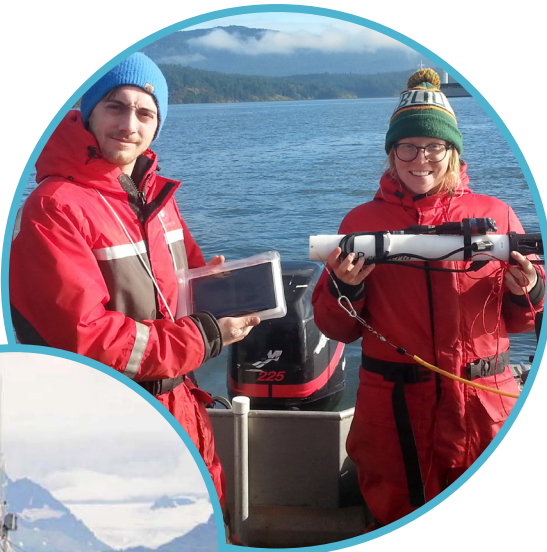
How It Works

After the instrument is lowered through the water and retrieved, the collected data are transferred to the smart tablet. The data are stored on the tablet until a cellular or Internet connection makes it possible for the data to be uploaded to ONC's data management system, Oceans 2.0. Once the data are uploaded, quality assurance and quality control (QA/QC) processes are executed before the data are available over the internet, allowing users to access, download, and visualize the data for science and decision-making.

Community Fishers citizen scientists are fully trained and paid to collect ocean data. Historically, oceanographic data collection relied on specialty research vessels and scientists in limited locations. These new tools reduce the high cost for measurement while increasing the geographic range of quality measurements.

Community Fishers data are collected in collaboration with Pacific Salmon Foundation in the Salish Sea, Canadian Rangers' Ocean Watch (CROW) with Fisheries and Oceans Canada in Nunavut, and various Indigenous communities in British Columbia and Nunavut.

This project for Iqaluit and Frobisher Bay is proposed in collaboration with Nunavut Arctic College with funding from Fisheries and Oceans Canada.

To the City of Iqaluit mayor and council.

Hello, my name is Claude Paiement, I am co-producer for an UK/Canada television miniseries called *The North Water* which portrays the events of a doomed whaling expedition in the Arctic in the mid-nineteenth century.

The sixth and last episode of the series takes place on Baffin Island, where the hero, a young doctor on board the sunken whaler, will first survive from a polar bear attack before being rescued by two Inuit hunters. He will then learn from the hunters the rudiments of traditional Inuit way of life as well as seal hunting. In return, he will use his medical skills to save somebody from certain death.

We would like to shoot 5 days in Iqaluit, from March 19th to March 23rd, 2020.

Two days of filming will take place on the ice near Tarr Inlet, where we will film the scenes of:

- 1- the hero chasing the bear (which bear will be filmed in a studio and added later by visual effects);
- 2- the hero being rescued by Inuit hunters, and the hero learning traditional seal hunting.

The following days will take place in Apex:

- 1 ½ day of filming in Rotary park, where we would build a façade of an English Mission where the hero meets a priest; we have shot the interior scenes in studio, already;
- 1 ½ day at the ex-dump in Apex, where we will build a Winter camp (igloos) and also an igloo large enough to be able to film inside.

Our Iqaluit team is primarily Inuit, and we aim to hire as much local crew as possible. We already have recruited our Outfitter (Polar bear), the transport crew (mainly Polar bear), the mechanics, the master igloo builder, the dog teams and trainers, the construction team (Caucasian owner with all Inuit crew), the seamstress. We are looking for other local additions to technical departments.

We also have the chance of having Ellen Hamilton for advising and guiding us on various issues, namely on the casting and human resources.

We are also hiring 14 players, all Inuits. All cast is paid and treated according to the Alliance of Canadian Cinema standards and rules.

Our needs in Apex:

A) Filming Sites

1- The Rotary club park:

a) area on the left-hand side of the road to build our 3 wall "Exterior Mission façade";

Construction and preparation dates:

March 10th to March 20th approximately; (we will define these dates more precisely soon, but we will ask for more time than needed in case we would be slowed down by bad wind or weather conditions;

Shooting dates: Aiming for March 21st and 22nd

Restoring and cleaning: March 23rd & 24th, or directly following the shooting.

2- The ex-dump area:

Igloo construction and set preparation: March 11th to March 17st. Exact dates to be determined, this can be much less. Precisions will come after planning with the igloo builder.

Shooting: Aiming March 20th and 23rd

Restoring and cleaning: March 24th.

3- Iqaluit bay, around Tarr Inlet Area.

No construction or installation except for warming tents and portable shelters

Approximately 2 days: on the 19th if weather permits, and another day no later than the 23rd of March.

Research Purpose

The data collected will only be used as part of this research project. Access to interview data will be restricted to the researcher.

Reporting

The research results will be communicated to the individual participants and Arctic Co-operatives Ltd. by email. The research will also be communicated to Iqaluit through a plain language publication.
