He recognized and thanked the Fire Chief and his firefighters for the excellent work in responding to the fire on January 5<sup>th</sup>.

Councillor Akumalik recognized and thanked the search and rescue team for finding the hunter who was missing during the Christmas week; he was returned home safely. He also recognized and thanked the Public Works Department for their hard work and dedication over the Christmas season.

Councillor Nattaq noted that the Hunters and Trappers Association now have devices that can be used when going on the land so that individuals can be found if their snowmobiles break or if they have any other issues; he highly recommended that all individuals going on the land use them.

Councillor Wilman expressed her concern with the number of fires in the community and suggested that the City release a public service announcement

reminding residents that lighters or any other dangerous items should be kept in a safe location to prevent fires.

Councillor Dobbin suggested that the City enforce a curfew during the winter months to ensure that youth are home no later than 10:00pm or 11:00pm.
