She noted that the subject of the film is quite sensitive but important and is based upon a true story out of Kugluktuk where there was a rash of suicides. The film aims to be a positive and inspiring one that tells the true story of a group of youth in Kugluktuk who banded together using sports to fight for themselves and their own lives and to pull their community out of the terrible situation they were in.

The film is important for all Nunavummiut as it faces a tough subject with positivity and hope and tells the story of youth who empowered themselves to reclaim the will to live and to live positive, healthy lives. It is a very powerful story told with sensitivity and the heavy involvement of Inuit including the very youth that the story is about.

There are a couple of scenes in the film that take place in a graveyard and that is why they are here. They would like Council's blessing to film in and around the graveyard and to also seek guidance on how to do so as respectfully as possible.

Councillor Akumalik thanked the delegation for attending and asked which graveyard they are referring to and when they need to know whether city approves or not. The delegation noted that it would be the old cemetery and as soon as possible for the decision would be appreciated.
