**3. DELEGATIONS**

- b) Annabella Piugattuk  
Citizen at Large

Ms. Annabella Piugattuk thanked Council for giving her the opportunity to present. She stated that she was in attendance during the discussions relating to the proposed Responsible Pet Owner and Inuit Dog By-law as she feels that this is a very important matter. She explained that she was brutally attacked by a pit bull, belonging to her neighbor, on July 15, 2012. She moved into building 240 approximately three years ago and was advised by the Iqaluit Housing Authority that new tenants who already owned a dog could keep their dog when moving into their unit, but could not acquire a dog once moved in. Her neighbor already owned a smaller dog before moving into the unit and was allowed to keep it but was advised that she could not acquire a new dog while living in the unit.

Approximately one year after her neighbor moved into her unit, she acquired a pit bull. Ms. Puigattuk believed that the pit bull was very aggressive at an early stage and contacted the Iqaluit Housing Authority as she felt that her and her children's lives were in danger; she expressed her concern to them with the fact that the dog's leash was very long and the dog often stood near her stairs as well as the fact that the dog's doings were all around her stairs. She also contacted the Municipal Enforcement Department on several occasions as the dog was loose. They responded and assisted her but sometimes the dog would be gone when they arrived.

Ms. Puigattuk stated that she was attacked by the pit bull for duration of approximately twenty (20) minutes; her children were very young and watched the attacked. They love dogs and still do, but are now very scared of most dogs. She stated that she was very scared and thought that she was going to die; the dog would not let her go and did significant damage, the scars are there to prove it.

She believed that pit bulls were very dangerous and should be banned from Nunavut; their brain continues to grow at all times and they are prone to attack their masters even after careful training and a lot of love. There are many provinces in Canada that have banned pit bulls and Nunavut should consider doing the same. Inuit went through a very difficult time when the banning of huskies was being considered and were very concerned as this was their method of transportation. There are all kind of dogs in Iqaluit and the number of dogs continues to increase.

Ms. Puigattuk understood that other dogs are also very aggressive and that huskies have attacked individuals in the past. There should be an assessment of individuals who want to own a dog before they are given permission to do so; there are many irresponsible pet owners in the world and often, they are the reason for vicious dogs.

Mayor Graham thanked Ms. Puigattuk for being courageous and sharing her very unfortunate experience with the animal. He noted that the city has been working on the new proposed by-law and due to further comments received from residents, there will be a public meeting held to discuss the by-law further and additional meetings will be held to make possible changes.

Councillor Nattaq noted that he drives an all-terrain vehicle and is often followed by larger dogs; he often has to find ways to get the dogs to stop chasing him as they are scary. All dogs should wear a muzzle when being walked as some are very unpredictable and may be vicious even when they seem friendly.

He believed that the city needed to hire an Animal Control Officer who is not afraid of dogs as they deal with dangerous dogs on a regular basis.

Deputy Mayor Wilman noted that Greenland only permits husky breeds in the territory and expressed her support for that decision. The number of dogs in Iqaluit increases each year and the breeds vary.

**5. STATEMENTS**

Councillor Nattaq noted that he had a very busy summer and attended many events. He visited one of the mining exploration camps and had a community feast with the group. They are now completing their projects for the summer and will be sharing their plans for winter projects in the near future.

He noted that a boat had sank in 1994 while they were out walrus hunting. There was a bad storm that caused the accident but the individuals were very lucky to survive on their own in the ocean, for four days and four nights. He believed that these individuals should be recognized for their bravery and survival.

Councillor Akumalik thanked Qulliq Energy Corporation for installing the street lights in Tundra Valley; the area is now much safer and it is easier to see individuals who are walking in the area.

He noted that a very tragic accident occurred last month; a four year old child was hit by a vehicle and died. The community was very shocked and affected by this accident but supported the family in many ways. The Public Works Department should review current signage throughout the community and perhaps install additional signage in busy areas as well as school areas if needed; crosswalks should be painted so that they are more visible to drivers.

He expressed his support for the Public Works students who have been cleaning the community throughout the summer months; their work is very much appreciated.

Deputy Mayor Wilman believed that Qulliq Energy Corporation should receive a letter of acknowledgment for installing the lights in Tundra Valley; Council has been discussing this matter for some time now and is very grateful that they have finally been installed.

She noted that the community is much cleaner since the students in the Public Works Department have been hired; their hard work and dedication is much appreciated.

She stated that toys and clothes have been dumped on the beach area and would like the appropriate organization to address the issue; there may be an

individual who trying to establish a residence on the beach and this should not be permitted.

She supported Councillor Akumalik's suggestion that additional signage should be installed in busy areas as well as school areas and that crosswalks should be painted to be made more visible.

Councillor Morrissey stated that he received several complaints during the weekend regarding the water shutdown in the plateau Subdivision; many residents were not aware of the water shutdown. He requested that planned water shutdowns in the future be announced well in advance so that residents are aware.

He also believed that the Public Works students were doing a great job at cleaning the community and never seem to stop; their hard work and dedication is very much appreciated.

He also believed that crosswalks should be painted or well identified and suggested that the city consider installing the removable speed bumps during the summer months.

Administration stated that the applicant has applied for a development permit to build a semi-detached dwelling on Lot 189, Plan 3896, in Phase 3 of the Plateau Subdivision; the lot fronts onto Qajisarvik Road. To accommodate the semi-detached dwelling on the uniquely shaped lot, the building is located in such a

way that the corner at the front of the building encroaches into the required side yard setback. To address this encroachment, a variance is requested to reduce the side yard setback to two (2) metres from the required three (3) metres.

Administration advised that by appointing a Chief Municipal Electoral Officer, the city will be able to prepare and conduct a by-election in accordance with territorial legislation, the *Cities, Towns and Villages Act* and the *Local Authorities Election Act (Nunavut)*. The city would be appointing an experienced individual to provide

an element of objectivity to the election process and to prepare and conduct the by-election process at arm's length from city administration.

Councillor Morrissey asked if Mr. Kirt Ejesiak was the Chief Municipal Electoral Officer during the last municipal election, and if so, was the city satisfied with his services.

Administration confirmed that Mr. Ejesiak was the Chief Municipal Electoral Officer during the last municipal election and the city was very satisfied with his services.

Councillor Akumalik asked how much the by-election would cost.

Mayor Graham believed that the city had estimated approximately forty thousand (\$40,000.00) dollars and has sixty thousand (\$60,000.00) dollars in the elections budget.

- d) Request for Decision – Upgrades to Emergency Dispatch Center  
Record Management System (RMS)  
Luc Grandmaison, Fire Chief

Administration stated that a committee was established and led by dispatcher Steve Allen along with committee members Barry Rogers, and Brian Witzaney-Chown; this committee has been working since February 2013 on the upgrades and replacement of dispatch equipment and components.

Once a call for assistance is placed with the Iqaluit Fire Department, a file is created by dispatch. After the call is completed the firefighters complete the necessary information in the file in the records management system. This includes patient care information, billing and other actions they took on scene.

The current records management system has been in service for approximately ten (10) years and has not been updated or maintained in this time. Furthermore,



two years after installation of the current system, the company went out of business, no longer providing support. The core of the ambulance billing, patient care reports, statistics, data et cetera, is the records management system.

As a growing city and Emergency Services Department, a more accurate and reliable records management system is long overdue.

Administration stated that, following a tender call prepared by the Purchasing Department, no tenders were received. After the tender process, the Purchasing Department forwarded a specification sheet to the 911 Pro company whom had already, in the past, prepared and delivered a similar pick-up truck for the Municipal Enforcement Department.

The Purchasing Department worked on the final details with 911 Pro to supply and deliver a four by four emergency services vehicle; the new vehicle will be used by the Fire and Ambulance Departments. The goal is to have a support vehicle available at all times of the day at the fire station rather than using a specialized vehicle for operational needs, as is the current practice.

The vehicle will be used to transport additional firefighters to a scene, equipment and resources to and from the scene. This vehicle will be made available to officers and firefighters to conduct a multitude of activities including training, fire prevention, emergency and non-emergency response, fire investigation and any operational duties deemed necessary.

Councillor Morrissey asked what the current state of the Command 2 vehicle was.

Administration believed that it was in fair condition; it has been in service since 2000. There have been some damages to the body and it also has a cover on the back of the cab area which will be very useful for the Public Works Department.

Councillor Morrissey asked if the vehicle was not suitable for emergency services.

Administration noted that the vehicle has a lot of mileage and does have some mechanical issues; the Emergency Services Department needs a reliable vehicle.

Councillor Morrissey noted that the Economic Development Committee is investigating the feasibility of a business incubator accelerator centre in the city; this initiative is being led by Councillor Dobbin with the assistance of Kuthula Matshazi. Councillor Dobbin created a working group to examine the feasibility of such facility; the purpose of this facility would be to help entrepreneurs to get their ideas off the ground, into affordable rental space and provide services such as bookkeeping, reception services, legal and administrative services at a shared cost.

Part of the process is to determine whether or not such a facility is needed within the city or if there is a desire for such a facility. The working group has developed a survey which will be distributed to entrepreneurs within the city, to small businesses and will also be posted on the City of Iqaluit website; the committee will be requesting feedback from the public.

The new airport is being proposed in the North 40 area and Federal Road will become the main access road to the airport and the new gateway to the community. He understood that the road is the city's responsibility; he believed that everyone knew that Federal Road is in poor condition, and the development of the new airport will be proceeding in the near future and upgrades to Federal Road are not part of the development plan. The city should take advantage of the opportunity and partner with the Government of Nunavut to do necessary upgrades to Federal Road while required personnel and equipment will be in Iqaluit.
