BY-LAW #660

FORGIVENESS OF DEBT

A by-law of the Municipal Corporation of the City of Iqaluit in Nunavut to authorize the forgiveness of debts owing to the City; pursuant to the *Cities, Towns and Villages Act*, R.S.N.W.T., 1988, c.8, s.164(1) as amended by s.Nu.2003, c.2.

WHEREAS it has been determined that certain debts owed to the City are not collectable and should be forgiven for justifiable reasons.

NOW THEREFORE, the Council of the City of Iqaluit at a duly assembled meeting enacts as follows:

1. All those debts owed to the City of Iqaluit itemized in Schedule "A" attached hereto and forming part of this by-law are forgiven for a total of \$15, 319.46.

This By-Law shall come into effect upon third and final reading.
