THE CORPORATION OF THE CITY OF IQALUIT, NU BY-LAW No. 824

LAND DISPOSAL BY-LAW

A BY-LAW of the City of Iqaluit, a Municipal Corporation in Nunavut authorizing the City to dispose of a leasehold interest in land, pursuant to Section 131 of the Cities, Towns and Villages Act, R.S.N.W.T., 1988 c.C-8;

AND WHEREAS certain land is available for disposal by way of lease by the City of Iqaluit;

AND WHEREAS the City of Iqaluit and Habitat for Humanity, as directed by Council through motion 12-253, signed a Memorandum of Understanding on August 1, 2013 which states that the City shall award lots to Habitat to develop up to eight dwelling units when such lots will be available for disposal.

NOW THEREFORE the Council of the Municipal Corporation of the City of Iqaluit in a duly assembled meeting enact as follows:

- 1. That the Municipal Corporation of the City of Iqaluit is hereby authorized to dispose of the land listed in the attached Schedule "A" which forms part of this by-law, by way of a lease for a term of 30 years.
- 2. That the Mayor and Chief Administrative Officer of the City of Iqaluit, or lawful deputy of either of them, are hereby authorized in the name and on the behalf of the City of Iqaluit, to execute all such forms of application, deeds, leases, indentures, and other documents as may be necessary to give effect to this By-law and to affix thereto the corporate seal of the City of Iqaluit as the act and deed thereof, subscribing their names in attestation of such execution.
- 3. That the City lease to Habitat for Humanity, Iqaluit, pursuant to subsections .01(a) and (b), and 53.4(2)(b) of the Cities, Towns and Villages Act ("the Act"), subject to an order of the Minister, pursuant to subsection 53.5(6) of the Act, exempting the City from compliance with subsection 53.5(b)(i) of the Act and subsection 6(a) of the City's Land Administration By-law No. 365, as amended, on terms and conditions otherwise in accordance with said Land Administration By-law.
- 4. That this By-law shall come into effect upon receiving third reading.
