9. NEW BUSINESS

a) Request for Decision – Northwest Deposit Road – RFT Reference 2020-RFT-71

Matthew Van Strien, Procurement Agent, advised that a tender was called to build the remaining portion of the Trail Area Deposit Road up to the future landfill location and Northwest Aggregate Deposit. He noted that three bids were received. Staff is recommending awarding the contract to the lowest bidder, 5581 Nunavut Ltd., in the amount of \$3,148,498.50. Mr. Van Strien noted that this amount is below the approved budget amount for the project.

Councillor Akumalik inquired as to who owned 5581 Nunavut Ltd. Mr. Van Strien indicated that it is Nunavut Excavating.

Councillor Flaherty asked if any of the three tenderers were Inuit owned companies.

Mr. Van Strien advised that 5581 Nunavut Ltd. and Pilitak Enterprises Ltd. are Inuit ownership.

Ms. Elgersma explained that any project that the Government of Nunavut funds 51 percent or more, or is funded directly by the City's block funding, the Nunavummi Nangminiaqtunik Ikajuuti (NNI) process is included.

Mr. Van Strien confirmed that this is not an NNI project.
